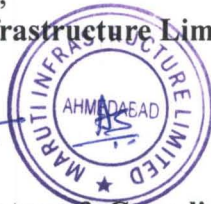

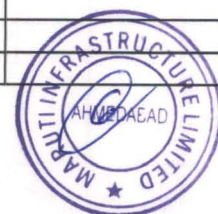

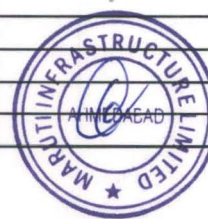

Notes :

2. The above results have been reviewed and recommended by the Audit Committee and subsequently approved by the Board of Directors at their meeting held on 30th May, 2022. The Statutory Auditors have expressed an unmodified audit opinion on the above result for the quarter and year ended 31st March 2022.
3. Figures for the quarters ended 31st March 2022 and 31st March 2021 are the balancing figures between audited figures in respect of the full financial year and the published year to date figures upto the third quarter of the relevant financial year.
4. Figures of the previous financial year/period have been re-arranged/ regrouped/re-classified/re-casted wherever necessary.
5. The Company's operations fall under single segment "Infrastructure Projects" and no separate segment disclosures have been made under Ind-AS 108 Operating Segment.
6. The Company is not a Large Corporate as per applicability criteria given under SEBI circular no SEBI/HO/DDHS/CIR/P/2018/144 dated November 26, 2018.
7. The Company has considered the possible effects that may result from the pandemic relating to COVID-19 on the carrying amounts of receivables, unbilled revenues, Tangible assets. In developing the assumptions relating to the possible future uncertainties in the global economic conditions because of this pandemic, the Company, as at the date of approval of these financial results has used internal and external sources of information including economic forecasts and consensus estimates from market sources on the expected future performance of the Company.

However the impact assessment of COVID-19 is a continuous process given the uncertainties associated with its nature and duration and accordingly the impact may be different from that estimated as at the date of approval of this financial result. The Company will continue to closely monitor the developments.

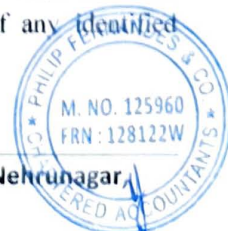
